Course Description

This course will explore the internal and external determinants of the recent global migration to Europe. During the semester researchers and experts will share the most important issues in their field with regard to migration and the refugee issue. Students will be introduced to the complex cultural, sociological, anthropological and psychological problems of migration. We will also discuss the political, legal and security aspects of migration and refugee issues and learn about the practical aspects of migration management and the possible means of corporate social responsibility. The 45-60 minute lectures will be followed by a group discussion.
